### First aid measures

## 5. Fire-fighting measures

- Extinguishing media** : Recommended: alcohol-resistant foam, CO<sub>2</sub>, powders, water spray.  
Not to be used : water jet.

## 6. Accidental release measures

- Spill** : Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). ## 7. Handling and storage

- Handling** : Keep container tightly closed.
- Avoid contact with skin and eyes. Avoid inhalation of vapor, spray or mist.
